# Terms and conditions

## 1. The Photo Book

If Davey Morgan Photography's Photo Book Suppliers change their Photo Book's availability, pricing, options, or selection and Davey Morgan Photography cannot provide the same Photo Book originally agreed to, Davey Morgan Photography is not obligated to provide the Photo Book, but will do its best to select a similar or like Photo Book or will take additional payment to cover any additional costs. If the Client does not agree to or cannot make an additional payment to cover a price change and Davey Morgan Photography cannot provide the Photo Book, the Client will not hold Davey Morgan Photography liable or responsible and will forfeit the right to the Photo Book and the Client shall not receive any refund or payment. Davey Morgan Photography is not responsible or liable for the inherent qualities of Photo Book, including fading, discoloration, or any other faults in manufacturing or normal wear and tear. Davey Morgan Photography shall mail or deliver the photo book, to the Client no later than forty five (45) days after Client approves the Photo Book Preview. Davey Morgan Photography is not responsible or liable for any delays in mail/delivery services or delays in processing the Photo Book due to suppliers. The photo book shall be limited to photographs exclusively from Davey Morgan Photography. Shipping is free and we only ship within the Contiguous United States. All Photo Book sales are final and there are no refunds.

## 2. The Photo Book Preview, Design Process, and Changes

The Photo Book Preview will be delivered no later than seventy (90) days after the wedding ceremony date. The Client is responsible for being able to and know how to access the file. Davey Morgan Photography will make changes the Client requests if reasonable at Davey Morgan Photography's discretion. The Client is limited to 2 revisions not changing more than 25% of the design. Davey Morgan Photography will make changes and send a new Photo Book Preview within ten (10) days of each revision. Additional revisions are \$50 each, limited to 10% of the design. If The Client does not approve of the Photo Book Preview after the allotted and/or paid revisions changes within thirty (30) days or does not approve the original Photo Book Preview within ninety (90) days, Davey Morgan Photography is not liable to provide The Photo Book, and will not return or refund any payment made.

## 3. Miscellaneous

The Client agrees to indemnify and defend Davey Morgan Photography against any and all claims, liability, damages, costs, and expenses, including legal fees and expenses arising out of any guests or person's injuries from Davey Morgan Photography's equipment or Photographers. Any breach of contract by the Client will release Davey Morgan Photography from this contract and no refunds or Photo Books will be delivered.

## 4. Agreement

This agreement incorporates the entire understanding of the parties. Any modifications of this agreement must be in writing and signed by both parties. Any waiver of a breach or default thereunder shall not be deemed a waiver of a subsequent breach default of either the same provision or any other provision of this Agreement. The laws of the State of South Carolina and the United States of America shall govern this Agreement.
